Subject: Raffle Tickets Sales

Our 2026 goal is to sell ALL 6,000 tickets! **Last year we sold a total of 3,702 tickets!!!** Team and individual competitions help us achieve our goal! Let's get to 6,000 this year!

### **Individual Contest (Includes Individuals on a Team)**

- To be eligible to sell tickets you must be at least 18 years old and an employee, registered volunteer, or board member of OHSCI. If you are not sure if someone is a registered OHSCI Volunteer, please contact Tabitha.
- **DO NOT GIVE YOUR TICKETS TO SOMEONE ELSE TO SELL!**
- Cash prizes will be awarded to the Top 3 sellers and to the seller of the winning ticket only if applicable. Competition will run until noon on Thursday, August 27th: 1st prize \$100, 2nd prize \$50, 3rd prize \$25, AND the seller of winning ticket prize \$50. **Please note that all unsold tickets, money from sales of tickets and ticket stubs must be turned in no later than noon on WEDNESDAY AUGUST 26th.**
- Prize drawings will be held twice a month and will be on the following dates: Thursday July 15th, Thursday July 29th, Thursday August 12th, and Thursday August 26th. **Your name will be entered once for every 10 tickets you sell and turn in by NOON on WEDNESDAYS!**
- We will be giving away 8 PTO days again this year! One day will be given away each week starting Thursday, July 9th! You must turn in 10 tickets sold and payment to be eligible. Once you have one, you may not win again.
- **Final prize drawing will be held on Thursday, August 27th.** The winner can choose between a PTO day OR a prize to be announced later. Volunteers entering the contest will be eligible to win a prize that we will announce later. Winners of the bi-monthly prize drawings and anyone who sells at least 50 tickets will be eligible to win the final prize.

### **Team Contest**

- Teams - no more than 10 individuals: Team captains are responsible for motivating and encouraging their team and making sure that individual team members turn in cash/checks and ticket stubs in a timely manner. **DO NOT give tickets to others that are not on our license or on your team to sell your tickets!**
- **Team competition will run until noon on Wednesday, August 26th.** The winning team will be announced by 5:00 pm on THURSDAY, August 27th. Team prizes will be awarded at a later date.
- Please note that all unsold tickets, money from sales of tickets and tickets stubs must be turned in no later than noon on Wednesday, August 26th.

## Rules and Regulations

### Seller Rules

- **Must be an employee or registered volunteer of Our Hospice or Palliative Care. If you are a Personal Care employee, you must register as a volunteer to sell.**
- **DO NOT GIVE YOUR TICKETS TO ANYONE ELSE TO SELL.** Tickets sold by individuals not listed on our license are subject to fines from the state, as well as penalties for Our Hospice.
- Must be 18 years of age and have no felony convictions to sell.
- You may not purchase tickets from yourself. If you wish to buy tickets, you must purchase them from a teammate or another employee.
- **YOU MAY NOT SELL TO THOSE WHO LIVE OUT OF STATE UNLESS THEY ARE PHYSICALLY IN THE STATE OF INDIANA AT THE TIME OF PURCHASE.** They must return to Indiana to receive payment. We are not licensed to conduct sales with out-of-state residents unless the transaction occurs within Indiana, as we are not licensed to conduct gaming in other states.
- If you are promoting raffle tickets on social media, please do not create your own posts. Instead, share posts from Our Hospice. By law, our raffle license number must appear in all printed marketing and must be stated verbally in any radio or podcast promotions.
- All transactions must be paid by cash or check only.
- If you would like to sell at an event or place of business (with prior permission), you must obtain approval from Tabitha. Proper signage must be displayed.
- Your name must be written on the back of each ticket prior to turning it in.
- If you are working at the concert on September 5, you are not legally allowed to purchase raffle tickets that day. Please purchase them in advance.

### Purchaser Rules

- Must be 18 years of age or older to participate or purchase.
- The purchaser's name must be on the ticket. Names of minors or any individual under 18 are not allowed.
- Must be physically located in the State of Indiana at the time of purchase. If the purchaser lives out of state, the transaction must occur face-to-face within Indiana, and they must return to Indiana to claim their prize.
- Payment must be made by cash or check only. Credit card payments must be processed at the center by authorized staff.
- Employees may purchase tickets from other employees, but not from themselves.

### Violations

Our Hospice is licensed by the Indiana Gaming Commission to conduct this raffle. Violations may result in fines for both the organization and the individual. Our Hospice will **not** pay fines resulting from employee violations.

#### Penalties include:

**Up to \$1,000 for a first violation.**

**Up to \$2,500 for a second violation.**

**Up to \$5,000 for each additional violation.**

Each ticket may count as a separate violation, and an additional \$100 per day may be added for unpaid fines.

## PTO Drawing Rules

- 1.) For each employee that turns in 10 tickets sold with payment, they will get their name in the eight weekly drawings for one (1) PTO Day. Once an employee wins a PTO day, they are no longer eligible for the remaining drawings.
- 2.) Tickets **MUST** be sold by Employees **ONLY!** You **MAY NOT** give your tickets to someone else to sell for you.
- 3.) Employees may turn in more than 10 tickets sold but will only get their name in the drawings one time. The rules for other contests do not apply to this drawing. Employees may still have multiple chances to win the other bi-weekly prizes.
- 4.) Employees must be an employee who is listed on our raffle license with the Gaming Commission.
- 5.) Tickets must be turned in by 4 p.m. on **WEDNESDAYS** to be eligible to win a PTO day. We have 8 days to give away!

## Important Information

- ◆ The cost of each raffle ticket is \$10!
- ◆ Individuals must be 18 years or older and listed on our Indiana Gaming License to **sell or purchase raffle tickets. This includes names put on the stub of the raffle ticket. No one under 18 may have their name put on a raffle ticket stub for the drawing.**
- ◆ ***You MAY NOT purchase tickets from yourself!***
- ◆ ***You MAY NOT sell to those living out of state unless the transaction is done face to face in the State of Indiana. They MUST return to Indiana to claim their prize.***
- ◆ **Cash or check only for raffle ticket sales – Indiana Gaming Laws do not allow the purchase of raffle tickets with a credit card.**
- ◆ **Due to Indiana Gaming Laws: on the day of the concert, those selling tickets cannot purchase tickets.**
- ◆ Winner need not be present to win.
